PART 3 - Guarantee

This guarantee will constitute a continuing guarantee for the producer (named in Part 1), now and in the future.

In consideration of any agreements that I/we have entered into or will enter into with G3, I/we the undersigned, jointly and severally guarantee that if I am/we are in default under any G3 contract now or hereafter issued, I/we and each of us are responsible to pay to G3 the entire outstanding amount of any damages plus collection costs, until the balance is paid in full.

Without requiring any further consent or any notice (same being expressly waived), I/we assent and agree, and without discharging or in any way affecting our joint and several liability, that G3 may:

- grant extensions of time, renewals and indulgences to the producer;
- apply all other monies owing by G3 to the producer(s) against all outstanding amounts that are attributable to the Customer Number that is the subject of this continuing guarantee.

G3 shall not be bound to exhaust its recourse against any one of the producers or other parties or to hold or to exercise its right under any lien, statutory or otherwise, before being entitled to payment from me/us under this guarantee.

This guarantee shall continue to be binding upon me/us and my/our heirs, executors, administrators and assigns.

PART 4 - Signatures

I/We the undersigned solemnly declare that I/we have read, understand and agree to be bound by this declaration and continuing guarantee and that all information set forth in this form is true, correct and complete.

And I/we make this solemn declaration conscientiously, knowing that it is of the same force and effect as if made under oath.

The declaration must be personally signed by the individuals named in the Declaration (Part 2). The parties cannot sign on behalf of the joint operation, trade name or partnership and must sign in their personal capacity. This Continuing Personal Guarantee may be executed in any number of counterparts and all such counterparts taken together shall be deemed to constitute one and the same instrument.

To knowingly make any misrepresentation or wilfully furnish any false or misleading information with respect to this document is an offence under the Criminal Code.

G3 Farmers Equity Plan Eligibility Certificate

[To be completed by all Farmers who are eligible for Units]



The undersigned (the "Farmer") has or intends to enter into a contract for the delivery and sale of grain to G3 Canada Limited which, under the terms of the G3 Farmers Equity Plan, may entitle the Farmer to receive units of the Farmers Equity Trust, in the event that the Farmer is determined to have met the criteria for eligibility. In that regard, the Farmer acknowledges having received a copy of the disclosure information regarding the G3 Farmers Equity Plan entitled *Important Information about the Farmers Equity Trust and the G3 Farmers Equity Plan*, which is posted on the website of G3 Canada Limited at www.g3.ca/fep and which also accompanies this Certificate.

The Farmer represents and warrants to G3 Canada Limited and the Farmers Equity Trust that:

- A. The Farmer is an individual, corporation, partnership or other entity or organization engaged in the production of grain, or entitled to grain produced by a farmer operating a farming business, and is resident in one of the Provinces of Manitoba, Saskatchewan, Alberta or British Columbia.
- B. The Farmer is *not* a "tax exempt person" as that term is defined under section 149 of the Income Tax Act (Canada).
- C. The Farmer has read the representations, warranties and acknowledgements contained in the *Important Information about the Farmers Equity Trust and the G3 Farmers Equity Plan*, and confirms that all are accurate and true.

The Farmer acknowledges that non-residents of Canada and tax exempt persons are not entitled to receive or permitted to hold units of the Farmers Equity Trust, and any issue or purported transfer of units to such a person shall be deemed to be void.

Upon execution of this Certificate, the undersigned will be deemed to have made all of the representations set out above and certifies the accuracy of all such statements. The undersigned further undertakes to notify G3 Canada Limited and the Farmers Equity Trust of any changes to the information provided herein.

The undersigned hereby authorizes G3 Canada Limited to provide this Eligibility Certificate to the Farmers Equity Trust and its transfer agent, Alliance Trust Company, and further authorizes G3 Canada Limited to provide the Farmers Equity Trust and Alliance Trust Company with information regarding the volume of grain sold and delivered to G3 Canada Limited by the undersigned for the purpose of determining the undersigned's entitlement to trust units. Upon delivery of this Eligibility Certificate, Alliance Trust Company will contact the Farmer to confirm information required in order to issue trust units. The undersigned acknowledges and agrees that information regarding the trust units issued to the undersigned may be disclosed by Alliance Trust Company to G3 Canada Limited.
